JUDICIAL INFORMATION

Christian Maton (assumed name « France Europe Beslan ») condemned to 3 months imprisonment, 10.000 € fine and 22.000 € compensation to his victims.

Court decision / file N° 16/2265 of the 9th chamber of the Court of Appeal of Versailles dated November 8th 2017, condemning Christian Maton (assumed “France Europe Beslan”) for cyber criminality after having wilfully damaged the support to the victims of terrorism during several years, acting from the computer facilities of the RATP transport organisation and from his home.

The Court condemned him to a 3 month imprisonment for having committed these offenses, falling under ART. 321-1 of the French Penal Code, 10.000 € fine and 22.000 € compensation to the association “Solidarité Enfants de Beslan”.

The court decision is providing for a suspended prison sentence. In the event that a subsequent criminal decision of justice would be pronounced against him within 5 years from the current decision the 3 month sentence could then be effectively applied. This could actually happen when one remembers the civil complaint lodged against him for subsequent fraudulent access to computer systems (Court decision N° 2016/05831 file B15330900557 dated February 9, 2017 – 7th chamber of the Paris Court of Appeal).

Christian Maton (assumed name « France Europe Beslan ») has already been condemned on October 11, 2011 for his first wilful damages to the support to the victims of terrorism in Northern Ossetia (decision N° 11/00362 by the 4th chamber of the Grande Instance Court of Justice of Créteil).

Christian Maton has been excluded from cultural (CLCR) and humanitarian (SEDB) associations for extremist political propaganda (quote: “the little value that Russia considers human beings explains the millions of people dead during the great patriotic war”). These words imply an official strategy to bring Russia into disrepute and make her liable for the casualties suffered during the Beslan terrorist attack.

One should note that Christian Maton (assumed name « France Europe Beslan ») is also a member of AFVT (French Association of the Victims of Terrorism)!

Ill-willed people are infiltrating any and all social groups, e.g. the association created for the victims of the Nice terrorist attack “Promenade des Angés 14 juillet 2016” has discovered the criminal offense committed by its general secretary Vincent Delhomme Desmaretz who for his own profit embezzled donations made to the association. The chairperson Emilie Petitjean addressing its members refers to him as a crook and took an action against him at the Nice Tribunal de Grande Instance!

Despite the misfortunes sustained in this world and in particular the ones aimed at our association we carry on with our fights for rehabilitating the victims of the same Islamic terrorism which is overtaking Beslan, Paris and Nice.

You can rely on us and our faithfulness just as we expect your friendship in pursuing our goals...let us pass it round !
